



Anonymous Counseling Program

FOR EDUCATORS, PASTORS,
EXEMPT OFFICE EMPLOYEES,
AND THEIR FAMILIES

The Anonymous Counseling Program offered by the Potomac Conference of Seventh-day Adventists is designed to meet the needs of pastors, educators and other full-time, exempt employees and their families who experience personal and/or family conflicts of a sensitive nature that require complete anonymity.

Recognizing the potential for such conflicts to impair the personal and professional lives of its ministers and educators and the sensitive nature of counseling needs, conference administration has developed the following Anonymous Counseling Program.



Who is included to receive this benefit?

- All full-time pastors, teachers, conference exempt personnel and their spouses are eligible to receive up to four counseling sessions per year.
- Dependent children of workers are available on request of the parent(s).

Who are the Counselors?

- Approximately thirty counselors have agreed to work with this program. Geographic areas of the conference are represented and other needs and preferences are taken into account, such as male and female counselors, Seventh-day Adventist and non-Seventh-day Adventist counselors where possible and those who work with children.
- Employee/clients must use the counselors on the provided list except under special circumstances and by prior authorization.

How are the counselors chosen?

- Counselors are chosen from seven primary regions within the conference so that employees have access to a counselor in their area.
- Although every attempt has been made to include Seventh-day Adventist counselors, all come from a Judeo-Christian background and are sensitive to those values. Many have been involved in ministry at some point in their career.
- Counselors are chosen carefully, and are subject to the following criteria:
 - Have the proper education and credentials.
 - Be licensed according to their specialty – Marriage/family therapist, clinical psychologist, pastoral counselor, etc.
 - Be comfortable with Christian faith and lifestyle, preferably active within his/her own faith.
 - Be willing to accept this program and pay scale.
- It is beneficial for counselors to have had experience in the pastorate or parochial educational system.
- Counselors considered for this program have been made aware of how the program works. Personal communication either by phone call or email has been made to answer any questions. The communication included a review of the criteria as listed above.



- The Administrative Committee votes on the counselors to be used in the program.
- Finding counselors to fit the criteria is not always easy, but inquiries among trusted counselors and pastors of mainline faith communities have proved to be very helpful.
- Counselors wishing to be considered for participation in this program can contact the Benefits Assistant in the HR department of the Potomac Conference for additional information.

The health insurance offered by the conference includes a benefit for Mental Health Services and most family/individual counseling situations should utilize this benefit. The Anonymous Counseling Program is intended to be used for conflicts of a sensitive nature that require complete anonymity.

Who is included to receive this benefit?

- Four coupons are issued at the beginning of each year or at the time of new employment. Along with the coupons, the employee receives a copy of the anonymous counseling brochure which includes counselor listing and contact information.
- The employee makes an appointment with any counselor on the list.
- The employee provides one coupon for each session with the co-payment.

How are counselors paid?

- The counselors have agreed to a discounted fee. In the Greater Washington area, the usual hourly rate for counseling ranges from \$75 to \$200. We have contracted for \$110.00.
- The employee/client is required to pay \$15.00 co-payment. The conference pays the remaining balance up to \$95.00. The primary reason for the co-payment is to help the employee take the counseling seriously.
- We pay only slightly less than most insurance plans. The program, even with the discounted fee is attractive to counselors because no reports are required and would, in fact, not be accepted. Many insurance plans require detailed reports of every session.

- One session is defined as a one-hour time with the counselor. Two hours at one appointment would require two coupons.

How does the counselor receive payment?

- The counselor bills the conference for each session using a client number that the counselor assigns.
- The only information on an invoice: assigned client number, dates of service, total charge, co-pay collected, balance due and an original coupon (not a copy) for each session.
- No identifying data such as name, address or telephone is accepted. If an invoice is received with identifying data through a billing error, it is returned to the counselor for re-issue. (The HR Benefits Assistant receives and processes the invoices before sending the vouchers to the treasury department for payment.)
- No diagnosis code is to be on the bill.

What are the safeguards to prevent misuse of the program?

- Special coupons are issued to each employee and each spouse. They are printed on security paper – sometimes called “check stock.”
- The conference provides a list of eligible employees to the counselors. This is updated periodically – usually about every six months.
- At the time of first visit, the employee must identify to the counselor that they are using the program and must present proper identification, such as employee identification or driver’s license. Counselor will then check identification against the above referenced employee list.

What if someone needs more than the four visits allowed?

- The Vice President for Administration along with the Human Resource Director is authorized to issue addition coupons as needed.
- The client usually is the person to request addition coupons, although a counselor may also do so, especially if there is a sensitive situation where anonymity is critical.
- Those with the authorization privileges check with one another when additional coupons have been authorized. It is done confidentially unless the employee requests otherwise. It is usually a simple statement such as, “I gave one of our pastors extra coupons because I felt that he/she needed or requested them.”
